Accept Bartle Wells Associates Rate Study and Direct Secretary to Mail Notices of Rate Hearing to be held May 25, 2019 in compliance with Proposition 218

March 7, 2019

RECOMMENDED ACTION: Resolution to accept Bartle Wells Rate Study and direct Secretary to mail Notice of Public Hearing to be held May 25, 2019 pursuant to Proposition 218.

BACKGROUND: Leland Meadow Water District provides water and wastewater services to the Customers in the District. The current user fees for water and wastewater services are insufficient to meet both the current financial requirements of the District as well as future financial requirements of the District.

During a Special Meeting January 2, 2019, the District Board approved hiring Bartle Wells Associates, a public finance consulting firm to conduct a Rate Study under direction of General Manager to recommend rates designed to provide adequate funding for ongoing operating and capital costs to support long-term financial stability in compliance with the legal requirements of Proposition 218. Bartle Wells Associates prepared a Rate Study March 6, 2019. The General Manager is proposing that the District Board accept this Rate Study.

In addition, and in compliance with Proposition 218, if the LMWD Board wishes to consider increasing rates, the District must deliver notice of the proposed fee increase to Customers and conduct a Public Hearing. Customers receiving the notice will be provided an opportunity to protest the increase, and, if a majority protest, the District may not implement the rate increase. The General Manager is proposing that the Rate Hearing be conducted at the next regularly scheduled LMWD Board Meeting Mary 25, 2019 at 11 am.

FISCAL IMPACT: Adoption of this resolution will have no Fiscal impact.

OPTIONS: The Board can adopt this Resolution, reject this Resolution or send it back to the General Manager for additional review.

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE LELAND MEADOW WATER DISTRICT TO ACCEPT BARTLE WELLS ASSOCIATES RATE STUDY AND DIRECT DISTRICT SECRETARY TO PREPARE AND DELIVER NOTICE OF A PUBLIC HEARING TO BE HELD MAY 25, 2019 TO INCREASE WATER AND WASTEWATER USER RATES, PURSUANT TO PROPOSITION 218

WHEREAS, the Leland Meadow Water District ("<u>District</u>") provides potable water and wastewater services throughout the District; and

WHEREAS, the user fees for potable water services are insufficient to cover the costs of providing those services; and

WHEREAS, the user fees for wastewater services are insufficient to cover the costs of providing those services; and

WHEREAS, the District must also insure adequate revenue to meet future financial obligations; and

WHEREAS, the District hired Bartle Wells Associates to conduct a Rate Study under the direction of the General Manager

WHEREAS, the District must comply with the substantive and procedural requirements of Proposition 218 when increasing water and wastewater user fees; and

WHEREAS, the District must deliver notice of the proposed fee increase to customers of record and conduct a rate hearing no earlier than 45 days after delivery of the notice; and

WHEREAS, customers receiving the notice will be provided an opportunity to protest the increase, and, if a majority protest, the District may not implement the rate increase; and

NOW THEREFORE, BE IT RESOLVED, the District Board of Directors does, hereby, accepts the Bartle Wells Associates Rate Study March 6, 2019.

NOW THEREFORE, BE IT FURTHER RESOLVED the District Board authorizes District Secretary to prepare and send notice of a public hearing to be held May 25, 2019 at 11 am, pursuant to Proposition 218, to consider increasing water and wastewater user rates.
